

- That the school will have control over any capital expenditure i.e., on land and the construction of building, its expansion and procurement of major equipment for the school.
- We shall generate funds for the needs of the school whether it is recurring or nonrecurring.
- That the school has the basic essential facilities such as laboratory equipment, equipment for games and sports and other co-curricular activities, Library books etc.

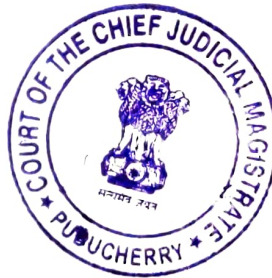

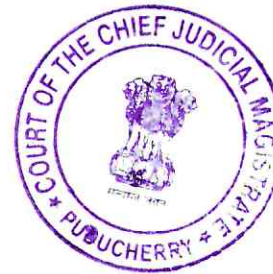
